

## WPMT MOTORCOACH GIVEAWAY OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. SUBJECT TO APPLICABLE FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.**
2. **Eligibility.** Subject to the additional restrictions below, the **WPMT Motorcoach Giveaway** (the "Promotion") is open to legal U.S. residents (excluding Puerto Rico) who are 18 years or older at the time of voting. Employees and contractors of **WPMT-TV** ("Sponsor"), TEGNA Inc., the Bailey Family of Companies, MCI/NFI parts, Saucon Technologies, and Imagineered Signs of York PA, and each of their respective affiliated companies, and advertising and promotional agencies, and the immediate family members of, and any persons domiciled with, any such employees or contractors, are not eligible to vote or to win.

Sponsor will not be responsible for incomplete, lost, late, misdirected, garbled, inaudible, or illegible votes, or for failure to receive votes due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or Sponsor. Ad blocking software on your computer needs to be disabled so that it doesn't interfere with processing your entry. By voting, you agree to receive e-mails from Sponsor or those directed by Sponsor.
